

LIMPSFIELD LAWN TENNIS CLUB
TABLE TENNIS SECTION
BYE-LAWS

1. NAME

The name of the club shall be Limpsfield Table Tennis Club

2. AFFILIATION

The club shall be affiliated to the English Table Tennis Association and the Surrey County Table Tennis Association.

3. OBJECTS

The objects of the Club shall be to allow members to practice, play and promote the game of Table Tennis and to operate in accordance with the English Table Tennis Association's equality policy.

4. MEMBERSHIP

The membership of the club shall be open to the following:

- a) Full Platinum member of Limpsfield Lawn Tennis Club (who has played Table Tennis at least 12 times in one year) – Senior/ Junior
- b) Associate Member – Senior/ Junior (Bronze)

The members of the club are under no financial liability by reason of membership of the Club except for annual membership fees.

Each member of the Club shall have his or her name, address and telephone number recorded by the Club secretary for the purpose of administration of the Club.

5. OFFICERS

The honorary officers of the Club, who shall be full members, shall be: Chair, Manager and Treasurer.

6. MANAGEMENT COMMITTEE

The Management Committee of the Club shall consist of its officers and not more than two other co-opted members.

If the post of any officer shall fall vacant, the Management Committee shall have the power to fill the vacancy until the next Annual General Meeting.

The Management Committee will arrange to meet on a regular basis and have the power to appoint sub-committees.

The Management Committee shall be the sole authority for interpretation of its constitution.

The Management Committee shall be the sole authority for the settlement of disputes relating to the affairs of the Club and the conduct of the members or of their guests.

The Manager of Limpsfield Lawn Tennis Club shall collect the fees and subscriptions and maintain an account on behalf of the members at a bank or building society.

7. DISSOLUTION

If at any General Meeting of the Club, a resolution be passed calling for the dissolution of the Club, the secretary shall immediately convene a Special General Meeting of the club to be held not less than one month thereafter to discuss and vote on the resolution.

If at that Special General Meeting, the resolution is carried by at least two-thirds of the full members present at the meeting, the General Committee shall thereupon, or at such date as shall have been specified in the resolution, proceed to realise the assets of the Club and discharge all debts and liabilities of the Club.

After discharging all debts and liabilities of the club, the remaining assets shall not be paid or distributed amongst the full members of the Club, but shall be given or transferred to some other voluntary organisation having objects similar to those of the Club.

8. INSURANCE

The club shall take out a public liability policy of insurance.

All members shall comply with the terms of the policy, a copy of which shall be held by the Manager and shall be available for inspection at reasonable notice.
